Lala Diwan Chand Trust was set up in 1930 and is registered under Section 12A (a) as a Charitable Institution since 1975 and is also registered under Section 80G of Income Tax Act, 1961. Lala Diwan Chand, an ardent follower of Arya Samaj, was a great philanthropist whose generously donated properties are willed to the Trust.

Management of the Trust

Activities of the Trust are managed by the Board of Trustees. During the year the Trust Board considered it desirable to induct Dr Ashok Haldia as Trustee on the Board considering his brilliant academic record as also rich and varied experience of working in high positions; the inclination and right attitude to devote himself by actively assisting in the execution of Trust projects.

During 2020-21, Trust Board could hold only 2 meetings due to COVID 19 pandemic, lock-down and effects thereof. Standing Committee of the Trust Board, which was set up in 2016 for regular review and follow up on implementation of decisions, could hold 2 meetings only. Sub-Committee on Investment of Trust Funds met 3 times to take timely decisions on matters related to investment of surplus funds.

During the year 2020-21 M/s Kumar Garg & Associates, Advocates served as Trust's Legal Advisor and M/s SP Nagrath & Co. LLP, Chartered Accountant were the Auditors and Tax Consultant.

Trust Board was serviced by the Trust Office headed by Hony. Director, Shri Shashi Kant Sahni.

Contribution to P M Cares Fund

The year 2020-21 has been year of COVID-19 pandemic affecting all sections of the Society and all types of economic activities.

The Trust has made a humble contribution of Rs. 5.00 Lacs towards P M Cares Fund.

Support to Diwan Chand Arya Senior Secondary School

Trust stands committed to extend requisite financial support to Diwan Chand Arya Senior Secondary School Society for running Diwan Chand Arya Senior Secondary School. All the Trustee are also the Members of the Society. Shri S.P. Puri, Chairman of the Trust Board is also the Chairman of the Governing Council of the Diwan Chand Arya Senior Secondary School Society.

During 2020-21, Trust provided donation of Rs 25.80 Lacs to Diwan Chand Arya Senior Secondary School Society for improved running of the School.

Donations to other Institutions:

The Trust has been giving donations to Charitable organizations engaged in public service for objectives conforming to the aims of the Trust; due priority is accorded to Arya Samaj Institutions for their public service-oriented initiatives particularly in the field of education, spread of Indian culture, medical and health-care. The endeavor has been to

focus on creation of tangible assets and ensuring sustainability of the project undertaken by the institutions.

During 2020-21, Trust supported 9 institutions, through donations amounting to Rs. 19.45 Lacs. A statement giving institution-wise details is annexed.

Lala Diwan Chand Charitable Hospital, Faridabad.

Focused efforts were made during 2020-21 to strengthen and further improve the functioning of the Hospital. The Hospital Advisory Board, continued to deliberate in depth all related issues, based on which several measures were taken for overall improvement in the functioning of the Hospital.

During the year Hospital attended to 10174 cases in OPD, 292 in dental care, 469 patients in IPD and 349 number of surgeries were done. The Hospital has to make efforts to serve larger number of cases to utilize its full capacity and the potential. Trust provided financial support of Rs 23.06 Lacs in 2020-21 to meet the revenue deficit in the Hospital budget.

Support to Indian Cancer Society- Delhi (ICS-D).

Trust was supporting ICS-D in care of cancer patients through the project ‘PRASHANTI’ which was being run in the Trust’s property at Lajpat Nagar under the framework of an MOU with Indian Cancer Society. As a Diagnostic Healing and Rehab Centre, PRASHANTI was providing useful service to the needy cancer patients. The work done by the Prashanti Centre included Bone Dexa Scan, Lymph press, Nutrition Programme, Breast Cancer (Cancer Sahyog) etc. However, Indian Cancer Society has moved in its own premises in March, 2021.

Development of Property at 2, Jain Mandir Marg, New Delhi.

Trust had entered into an Agreement with Intel in 1992 for development of the property at 2, Jain Mandir Road. However, in a court case filed by Sh. Jayant Gupta, there is ‘stay’ by the Court against any alienation of this property. Trust is contesting the case in the court. Trust is deeply concerned at ever prolonging court case and is anxious to see that the matter gets moving fast.

This occasion on 24th September 2020 was celebrated by organizing Havan at Trust office 2, Jain Mandir Road, New Delhi, serving lunch to about 150 students at Gurukul, Yousaf Sarai and holding Medical Camp at Faridabad Hospital; where free Consultation and diagnostic tests, and free medicines were provided to all OPD patients.
