Lala Diwan Chand - A successful entrepreneur, staunch patriot, passionate social reformer, devout Arya Samaji and ardent philanthropist. This multifaceted personality orphaned at the tender age of six years, went on to become one of Delhi's most affluent, influential and benevolent businessmen.

The journey was not easy as Lalaji belonged to a family of modest means, and due to financial constraints could study only till Class 3. Yet he overcame all the hurdles of life through hard work, determination, and personal sacrifice. Adversity and setbacks did not deter him, on the contrary strengthened his nerves and sharpened his skills.

More than Lala Diwan Chand's affluence and wealth, he was renowned for his generosity and social work. His legacy is etched in the minds of those whose lives he transformed, and his beneficence continues in the form of the present trust created by him - LALA DIWAN CHAND TRUST.

Lala Diwan Chand Trust was set up in 1930 and is registered under Section 12A as a Charitable Institution since 1975 and is also registered under Section 80G of Income Tax Act, 1961.

Meetings Held

During 2021-22, Trust Board held 2 meetings.

During the year 2021-22 M/s Kumar Garg & Associates, Advocates served as Trust's Legal Advisor and M/s SP Nagrath & Co. LLP, Chartered Accountant were the Auditors and Tax Consultant.

Lala Diwan Chand Memorial Hospital, Faridabad.

In memory of Late Lala Diwan Chand, the Trust is running 30 bedded general Hospital in his name “Lala Diwan Chand Memorial Hospital”

at Faridabad. The Hospital provides outdoor (OPD) and indoor (IPD) treatment in various specialties including Cardiology; Dental; Gynecology; E.N.T.; General & Ortho Surgery; Diabetes in addition to General medicine. The Hospital is equipped with required infrastructure and has latest medical equipments. All major diagnostic services including hematology, cytology, microbiology, biochemistry and histopathology etc. and 24/7 Chemist shop are available in the Hospital. Focused efforts were made during 2021-22 to strengthen and further improve the functioning of the Hospital. The Hospital Advisory Board, continued to deliberate in depth all related issues, based on which several measures were taken for overall improvement in the functioning of the Hospital.

During the year Hospital attended to 10396 cases in OPD, 292 in dental care, 383 patients in IPD and 468 number of surgeries were done. The Hospital has made efforts to serve larger number of cases to utilize its full capacity and the potential. Trust provided financial support of Rs. 24.40 Lacs in 2021-22 to meet the revenue deficit of Rs.40.62 lacs of the Hospital.

Support to Diwan Chand Arya Senior Secondary School

Lala Diwan Chand knew the importance of education, and curious for knowledge was incessantly engaged in discussion with seers. He gave a

blank cheque to Mahamana Pandit Madan Mohan Malviya for establishing Banaras Hindu University (Kashi Hindu Vishwavidyalaya) and from time to time continued contributing.

In keeping with the ideals of Lala Diwan Chand, the Trust stands committed to extend requisite financial support to Diwan Chand Arya Senior Secondary School Society for running Diwan Chand Arya Senior Secondary School. All the Trustee are also the Members of the Society. Shri S.P. Puri, Chairman of the Trust Board is also the Chairman of the Governing Council of the Diwan Chand Arya Senior Secondary School Society.

During 2021-22, Trust provided donation of Rs 27.75 Lacs to Diwan Chand Arya Senior Secondary School Society for improved running of the School.

Lalaji subscribed to the notion of economic inclusion and for developing the skills of the youth bequeathed a large sum of money towards industrial, technical and vocational based education scholarships for poor students. He stipulated that the scholarship holders be asked to execute an agreement in writing that they will refund the amount received by them so that the money could be reused in giving more scholarships and continuity is maintained with a greater number of students benefiting.

Donations to Other Institutions:

Lala Diwan Chand Trust was a highly benevolent man to whom philanthropy came naturally. Even when he was earning Rs. 10/- he would share it and on becoming wealthy he had no arrogance of his riches and became more open-handed.

The Trust has been giving donations to Charitable organizations engaged in public service for objectives conforming to the aims of the Trust; due priority is accorded to Arya Samaj Institutions for their public service-oriented initiatives particularly in the field of education, sports, spread of Indian culture, medical and health-care. The endeavor has been to focus on creation of tangible assets and ensuring sustainability of the project undertaken by the institutions.

During 2021-22, Trust supported 10 institutions, through donations amounting to Rs. 23.01 Lacs for various objectives conforming to the aims of the Trust. A statement giving institution-wise details is annexed

Birthday of Lala Diwan Chand, which falls on September 24, is an occasion to celebrate the life of great philanthropist and pay homage to his memory. This occasion on 24th September 2021 was celebrated by organizing Havan at Trust office 2, Jain Mandir Road, New Delhi, serving lunch to about 175 students at Gurukul, Yousaf Sarai and holding Medical Camp at Faridabad Hospital; where free Consultation
